Joel Scandrett reported on the progress of the journal on behalf of Todd Speidell.

Gary Deddo gave the treasurer's report.

Gary Deddo reported on our membership which stands at 170 and on the website.

### New Business

Paul Molnar reported on Victor Shepperd's health and announced his resignation from the executive committee.

Paul Molnar reported on publications featuring the work and theology of TF Torrance:

Paul Molnar announced that the Thomas F. Torrance Theological Fellowship has been invited by the Society for Biblical Literature to become an affiliate member group.
